

Section X - HeatherRidge Neighborhood Recreation Center Pool Rules

The rules and regulations established for the HeatherRidge pools are based on the Minimum Sanitary Requirements for the Design and Operation of Swimming Pools and Bathing Beaches, as published by the Illinois Department of Public Health.

- **Failure to comply with any of the below rules and regulations may result in violators losing their pool Privileges.**
 - **The cost of any property damage will be charged to the person or persons who are found responsible.**
 - **The Security Department is at all times an agent of the HUA Board, and is authorized to enforce the rules regarding the use of the swimming pools.**
 - **Report any pool malfunctions to Security.**
1. HeatherRidge pools are restricted to authorized residents possessing valid key cards, their children under 17 years of age and their guests. Children under 18 years of age and all guests shall not enter the pool area unless accompanied by an authorized resident or if a Guest Pass has been obtained.
 2. All residents entering the pool area must be prepared to show a HeatherRidge Key Card to the Security Officer on duty, as they make periodic identification checks. The use of the pool facilities implies you consent to present this identification when asked.
 3. The pool will be open daily from 9:00 am to 10:00 pm, if pool cleaning has been completed.
 4. The pool may be closed at any time due to breakdown, inclement weather, or other operational difficulties, and/or at the discretion of the HUA Board or the Community Manager.
 5. Guests must be accompanied by an authorized resident to use the pools unless a guest pass was issued. There is a limitation of four guests per dwelling unit on Saturday, Sunday, and holidays; and six guests per dwelling unit on Monday through Friday.
 6. Only persons dressed in clean swimwear shall be permitted in the pool. Cut-offs or tennis shorts are not acceptable swimwear. Toddlers and infants must wear specially designed swim diapers under swimwear.
 7. Persons entering the pool area and/or swimming alone, does so at their own risk. All persons will shower in the nude, before entering the pools as required by State Regulations. Additional showers are required after the use of greaseless suntan lotion (rather than suntan oils), and upon re-entry after leaving the pool area.
 8. Only children age five and under, while supervised, are permitted in the StoneyBrook/ Cambridge wading pool.
 9. Admission to the pool is refused to all persons having any contagious disease, infectious conditions such as colds, fever, ringworm, foot infections, skin lesions, carbuncles, boils, inflamed eyes, ear discharges, or any other condition which has the appearance of being infectious. Persons with excessive sunburn, abrasions which have not healed, corn plasters, bunion pads, adhesive tape, rubber bandages, or other bandages of any kind are not to be permitted in the pool area
 10. A person under the influence of alcohol or exhibiting erratic behavior shall not be permitted in the pool area.

11. Diving is not permitted. No running, pushing or roughhousing.
12. Any play equipment or floating apparatus shall not be allowed to interfere with other swimmers. No water balloons are permitted.
13. No abusive or profane language or excessive noise will be tolerated. Radios are permitted if operated on a low volume and are not objectionable to other persons.
14. No smoking is allowed in any HUA-owned facilities.
15. Expectorating or blowing of the nose in the pool is prohibited.
16. Wheeled vehicles, with the exception of wheelchairs and strollers, are not allowed in the pool area.
17. No glassware shall be permitted in the enclosed pool area.
18. No pets, other than service animals and animals required by doctor's orders, will be allowed at any time on recreational facility/pool premises or tied to the fence surrounding the pool premises. Under no circumstances are animals allowed in the water.
19. No wet swimwear is allowed inside the recreation centers with the exception of the restrooms. Dirty diapers must be removed from the facility, not left in the trash receptacles.
20. No fence climbing is permitted.
21. The pool area shall not be reserved except by special permission from the Neighborhood Committee for community-wide events sponsored by and/or established by the HUA Board.
